THE LINCOLN COUNTY ROTARY STUDENT LOAN FUND 2024 APPLICATION

The Lincoln County Rotary Student Loan Fund is dedicated to the education of our youth in Lincoln County. Educational loans made by the Rotary Student Loan Fund are made possible by the Rotary Auction and other fundraising efforts. The success of these fundraisers is the result of individuals and businesses providing funding, along with Rotarians and their spouses who donate many hours of hard work. Although the bulk of our funding comes from donations from the community, another major part of our ability to continue to provide loans stems from repayment of loans from former students.

REQUIREMENTS FOR OBTAINING A ROTARY STUDENT LOAN:

- 1. You must be a high school graduate or have obtained a GED, and be a current resident of Lincoln County.
- 2. You must have graduated from high school with a "C" average or above. If you have previously been enrolled in college, you must have a cumulative GPA of 2.0 (grades are required). If at any time your GPA falls below 2.0, no additional monies will be disbursed until your grades meet our GPA requirements.
- 3. You must be enrolled as a full time student. (12 semester hours for regular semesters or 9 semester hours for summer semester). If this is your first loan, you must provide proof of admission.
- 4. You must have two (2) Co-Borrowers to sign your promissory note. Your Co-Borrowers must be 18 years of age or older and live in Lincoln County. Co-Borrowers must be gainfully employed or own property in Lincoln County. (Both parents may co-sign your note if they meet the above qualifications.)
- 5. Applications must be filled out completely and submitted with a current transcript (all applicants) and proof of acceptance (graduating senior) or the application will be rejected.
- 6. All applications *must be completed and postmarked* by May 20th to be eligible for consideration for full funding for the upcoming school year. Official postmarks dated May 20th are acceptable proof of timeliness.

RULES GOVERNING ROTARY STUDENT LOANS:

- 1. Semi-annually you are required to pay the interest on your loan. $(1-1/2\% \text{ on or before June } 30^{\text{th}})$ and $1-1/2\% \text{ on or before December } 30^{\text{th}})$ (10% if in default). A 4% late fee will be assessed if interest is received late.
- 2. At the completion of each quarter/semester you must email a copy of your grades for that period (emailed to annabmullen@rotarylinc.org).
- 3. Six months after graduation your notes will come due. At that time you may either pay the amount you owe in full or we will set the amount up on sixty to one-hundred-twenty (60-120) monthly payments based on total loaned. You should contact the Student Loan Fund office at least two months prior to your 6-month grace period. The rate on your monthly repayment note will also be 3% (10% if in default).
- 4. If at any time you withdraw or are forced to withdraw from school, your repayment schedule will begin in accordance with the above paragraph. In addition, should you be enrolled in less than 12 semester hours for more than one year, repayment must begin in accordance with the above paragraph. *Each semester that you participate in the loan program, school verification is required.*
- 5. It is a condition of this loan that you inform us if you are no longer in school and of any address, phone or email change.
- 6. The decision to provide or deny a loan will be at the sole discretion of the Lincoln County Rotary Student Loan Fund Board of Directors. While the Lincoln County Rotary Student Loan Fund hopes to be in a position to make additional loans in future years, this application is for a loan for the upcoming academic year only and there is no assurance that additional loans will be available in the future.

1.	Application is filled out completely. (There can be no blanks. Please use N/A if it doesn't apply. Financial information is not optional.)
2.	Social Security numbers will be required at note signing and must be provided before payment is released. (If you are uncomfortable listing below, please plan to provide when signing promissory note).
3.	There are three personal references with complete addresses & phone numbers listed.
4.	Student & both Co-Borrowers have signed and dated the application
5.	Determined that both Borrowers & Co-Borrowers are residents of Lincoln County or own property in Lincoln County. If not, you are not eligible to sign this note, unless preapproved by the Rotary Student Loan Fund Board of Directors.
6.	Co-Borrowers have filled out their portion completely, including income, three credit references with complete addresses, phone #'s, account numbers (required) and balances.
7.	If this is NOT your first Rotary loan, attach a copy of your most recent completed grades if they were not mailed after the completion of your fall semester. If funded, you will be required to provide your spring grades & pay your semi-annual interest before funds can be released
8.	FIRST TIME APPLICANTS – Provided proof of acceptance at the school you will be attending. (Application is not complete without this information.)
9.	FIRST TIME APPLICANTS – Included a copy of your most recent transcript (high school or college).
10.	Are mailing to the correct address: LC RSLF PO Box 682, Lincolnton, NC 28093 no later than MAY 15th. Please make sure postmark date is legible. Applications received after May 20th without a May 20th postmark or an illegible postmark will not be considered. (Only an official US Postal postmark is acceptable proof. It is suggested that you take your application to the post office and ask them to postmark it to assure its legible).
11.	You have provided an email address where you prefer to be notified when your application is received (first blank
